 Purchases and Projects requesting for transfer of EC granted.
- Details of Physical process made on the facilities for which environmental clearance was granted. Built up area 25,139.33 Sq.m, FSI area 19,817.04 Sq.m, non FSI area 1,093.36 Sq.m, Parking 4,228.93 Sq.m. and has also furnished floor wise proposed activities in the said facility.
- 3. Undertaking letter signed by authorized person regarding acceptance of the terms and conditions in Environmental Clearance granted.
- 4. No Objection issued to confirm that M/s. Virgo Realtors Pvt Ltd had conveyed the property in favour of M/s. Sri Kauvery Medical Care (India) Limited vide Registered Sale Deed dated 1st July, 2021.
